Subject: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

Ref: Intimation dated February 17, 2026 in relation to search/ inspection by Department of Goods and Services Tax, Maharashtra

This is in furtherance of our earlier disclosure dated February 17, 2026, wherein it was informed that the Department of Goods and Services Tax, Maharashtra (the “**Department**”) had initiated a search operation at the Mumbai office of Medi Assist Insurance TPA Private Limited (“**Medi Assist TPA**”), a material wholly-owned subsidiary of the Company.

In this regard, we inform you that the closing submission for concluding said search operation has been submitted to the Department on March 2, 2026.

The Department has stated that on account of a non-compliance by a supplier (the defaulting party) in the remittance of applicable taxes, the unpaid tax amount along with the interest should be recovered from Medi Assist TPA. Additionally, the Department stated that Medi Assist TPA was also liable to pay accrued interest on holdback amounts in customer invoices. Accordingly, Medi Assist TPA has paid a sum of INR 4.83 Crores (being the aggregate amount of unpaid tax and interest for all alleged liabilities). The said payment has been made to avoid any penalty or additional interest charges, and without prejudice to Medi Assist TPA’s rights and remedies under applicable law, including its right to file appropriate representations and/or seek recovery.

Medi Assist TPA will continue to extend its support to the Department, if required. Business operations of Medi Assist TPA continue as usual.
